Estimated Base Costs for United States Intended Parents

At A Family Tree Surrogacy, LLC we strive to offer the most affordable and successful surrogacy journeys in the industry. We understand the surrogacy process is an intimidating financial commitment. Please know we are here to support you in any possible way throughout your journey. Provided below are estimated costs to assist in the planning of your surrogacy journey. Please note medical fees and other expenses the surrogate incurs are not listed and vary from clinic to clinic. These amounts are subject to change without notice.

A Family Tree Surrogacy, LLC Agency Fee: Locating and screening suitable surrogate candidates, facilitating meetings between intended parent(s) and potential surrogates, UNLIMITED surrogate matches, coordinating with other surrogacy professional (clinics, attorneys, etc), 24 hour support for both parties throughout the process pre and post-partum.

First payment (due upon signing of agency agreement)	\$4,500
Second payment (due upon signing of surrogacy contract with surrogate)	\$5,000
Final Payment (due upon confirmation of pregnancy by ultrasound)	\$3,000
Total Agency Fee	\$12,500

Surrogate & Intended Parent Non-medical Screening Expenses: Covers the cost of surrogates and partners (if one), and intended parent(s) comprehensive screening. Including but not limited to background checks, evaluations, home reviews, pre-match travel expenses.

Surrogate Trust/Escrow Account Management Fees: Trust account managed by a CPA with reporting.

Total Trust Account Management Fees (included with agency fee) FREE

Surrogate Compensation: Unlike your average agency A Family Tree Surrogacy sees the surrogacy process differently. We permit surrogates and intended parent(s) to determine a compensation that both parties are comfortable with.

Surrogate Compensation (varies depending on your budget) Average \$30,000 - \$40,000

Legal Fees: A Family Tree Surrogacy prepares the draft surrogacy contract. With the assistance of legal counsel each party will review and discuss the contract. The intended parent(s) will pay their own attorney fees as well as attorney fees for legal proceedings in connection with the establishment of parental rights. Legal fees vary and are paid directly to the attorney.
